## AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Pool operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

### About the audit

This report contains the results of our independent accountability audit of the Enduris Washington from September 1, 2016 through August 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Pool's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended August 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial Condition
- Insurance (claims administration)
- Procurement (bidding)
- Conflict of Interest/ethics laws

## INFORMATION ABOUT THE POOL

Enduris Washington is a local government risk-sharing pool located in Spokane County. The Pool was established in 1987 to provide risk financing to its members for general liability, automotive liability and property damage, mobile equipment and other property coverage common to public entities. The Pool provides services to over 500 local governments in Washington, which include, but are not limited to, public health, water, sewer, irrigation, weed, park and recreation, library, fire, air pollution control, mosquito control, port, regional support network, conservation and cemetery districts.

An elected, seven-member Board of Directors, composed of representatives from member governments, governs the Pool. For fiscal year 2017, the Pool had 13 employees and annual operating expenses of approximately \$15.2 million.
